**1. Terminalling Services**

Zydeco System Receipts

\$0.19 per Barrel

An Oil Loss Allowance of one-tenth of one percent (0.1%) will be deducted from the volume of Crude Petroleum received.

**2. Segregation Storage Charges**

Segregation Storage shall be charged as follows:

1. \$0.30 per Barrel for days 1 through 30
2. \$0.02 per Barrel per day for days 31 through 40
3. \$0.04 per Barrel per day for days 41 through 50
4. \$0.06 per Barrel per day for days 51 through 60

The \$0.02 per Barrel per day increase will continue every ten (10) days until the Crude Petroleum has been removed from Segregation Storage.

**3. LOOP Sour Storage**

Any Barrels remaining in LOOP Sour Storage not covered by a current CAC shall be subject to storage charges of the greater of \$0.50 per Barrel or three (3) times the Futures Clearing Price per Barrel from the most recent auction. For each month crude oil remains in LOOP Sour Storage, the storage fee will be readjusted in accordance with the preceding sentence.

**4. Blending**

Tank Blending

\$0.050 per Barrel

In-Line Blending

**5. Pumpovers**

\$0.050 per Barrel

**6. Crude Title Transfers**

\$0.006 per Barrel, with a minimum charge of \$150 per transaction

**7. Viscosity Surcharge**

Crude Petroleum having a Viscosity of 21 Centistokes (cSt) or greater at 104° Fahrenheit shall be subject to the following surcharge, as applicable:

<u>Viscosity Centistokes at 104° F</u>	<u>Rate Per Barrel</u>
21-108 cSt	\$0.010
109 cSt -300 cSt	\$0.020
301 cSt and above	\$0.025

**8. Crude Petroleum Quality Deviation Fee**

In addition to all other charges for transportation hereunder, all Crude Petroleum having a Water and Sediment Content over 1% or any non-produced material shall be subject to a fee of \$0.114 per Barrel for the entire gross volume of the Batch.

**9. Application**

This Terminalling Services Rate Sheet is governed by the Terminalling Services-Connecting Carrier Receipts Terms and Conditions of Service effective July 1, 2020, and amendments thereto and successive issues thereof.

**10. Rate Changes**

Rates are subject to change at any time prior to 30 days before the first of each Terminalling Services month.
